Introduction

The NYC Arts in Education Roundtable

The NYC Arts in Education Roundtable is a member-driven organization for arts in education professionals who collaboratively provide and participate in high quality professional development programs for the arts in education community. The Roundtable is the only organization exclusively dedicated to provided networking, skills building, and best practice sharing for arts educators in New York. Currently, there are 970 members, including 106 organizations. The Roundtable's programs are rooted in the need for high quality arts education programs. Our goal is to assist arts educators to do their best work, helping students succeed in and through the arts. The Roundtable's primary activities include our annual two-day **Face to Face** arts in education conference and monthly professional development programs.

The only event of its kind in NYC and the largest in the state, **Face to Face** is a professional development conference for arts administrators, teaching artists, and others interested in the field of arts in education. Face to Face is held over two days in April at The City College of New York, Shepard Hall. The conference strives to demonstrate effective teaching and learning strategies for practitioners in the field of arts in education, as well as to provide forums for discussion of other critical issues such as policy and advocacy, assessment, fundraising, and organizational management. The conference encompasses approximately 35 break-out sessions, keynotes, a plenary session, and two networking events.

NYC Teaching Artists Outreach Project

With the support of the New York State Council on the Arts, the NYC Arts in Education Roundtable is offering 10 subsidies to unaffiliated teaching artists to attend **Face to Face 2017**. Each subsidy includes the following:

- \$75 registration subsidy. (Registration rates range from \$120 to \$160 depending on member status and date of registration. Registration opens in mid-February 2017).

Recipients must commit to attending the entire two-day conference, from 8:30 AM to 5:30 on Wednesday, April 12 and 8:30 AM to 4:15 PM on Thursday, April 13, 2017.

Application Process

In order to be considered, applications must be submitted by **December 16, 2016** via the online form. Resume and proof of residency must be e-mailed to F2FNYSCAapplications@nycaieroundtable.org with your name and "NYSCA Re-grants" in the subject.

Applications will be reviewed by a panel of arts education professionals based in NYC.

PROGRAM CRITERIA

Successful applicants will:

- Not otherwise be registered by an organization with which he or she works.
- Live in the five boroughs of New York City (proof of residency required).
- Be able to articulate specific professional outcomes for participation in Face to Face 2017.
- Have a demonstrated commitment to his/her own professional development.

In order to be considered, applications must be submitted by **DECEMBER 16, 2016** via e-mail using the form below:

A complete application includes the application form, resumé, and proof of NYC residency.

Applications received after the DECEMBER 16 (11:59 PM) deadline will not be considered. No exceptions.
